MOTION: Sen. Okerlund moved to amend S.J.R. 16 as follows:

125 BE IT FURTHER RESOLVED that the Legislature of the state of Utah urges the

127 historic .scenic, or recreational trails, if the trails are determined by the board to be
 of statewide significance and to
128 meet other criteria as defined by the board.
