Rep. Dougall called the meeting to order at 3:28 p.m.

H.B. 31 Taxes and Fees on Emergency Medical Aircraft (*Rep. P. Painter*)

Rep. Painter introduced the bill to the committee.

MOTION: Rep. Painter moved to amend the bill as follows:

1. Page 1, Lines 18 through 19:

18 Other Special Clauses:

19 This bill { ~~takes effect on January 1, 2013.~~

provides an immediate

effective date.

This bill has retrospective operation to January 1, 2012.

2. *Page 4, Lines 92 through 93:*

92 Section 2. Effective date.

(1) If approved by two-thirds of all the members elected to each house, this bill takes effect upon approval by the governor, or the day following the constitutional time limit of Utah Constitution,

Article VII, Section 8, without the governor's signature, or in the case of a veto, the date of veto override.

93 (2) This bill ~~takes effect on~~ has retrospective operation to January
1, { ~~2011.~~ 2012.

H.B. 42 Permanent Community Impact Fund Board Grants (*Rep. P. Painter*)

Rep. Painter introduced the bill to the committee.

Spoke for the bill: Roger Tew, attorney, Utah League of Cities and Towns

MOTION: Rep. Newbold moved to pass the bill out favorably. The motion passed, with Rep. Dougall, Rep. Gibson, Rep. Harper, Rep. King, and Rep. Butterfield voting in opposition. Rep. Brown and Rep. Briscoe were absent for the vote.

Rep. Dougall relinquished the chair to Chair Painter.

H.B. 35 Extension of Recycling Market Development Zone Tax Credits (*Rep. W. Harper*)

Rep. Harper introduced the bill to the committee.

Spoke for the bill: Candace Daly, Institute of Scrap Recycling

MOTION: Rep. Hutchings moved to pass the bill out favorably. The motion passed, with Rep. Briscoe, Rep. Cosgrove, Rep. Eliason, Rep. Froerer, Rep. Gibson, Rep. King voting in opposition. Rep. Brown was absent for the vote.

H.B. 250 Tax Credit for Dependent with a Disability (*Rep. J. Dougall*)

Rep. Dougall introduced the bill to the committee.

MOTION: Rep. Barlow moved to pass the bill out favorably. The motion passed with Rep. Briscoe, Rep. Cosgrove, Rep. Duckworth, Rep. King, and Rep. Nielson voting in opposition. Rep. Brown, Rep. Froerer, Rep. Harper, and Rep. Newbold were absent for the vote.

H.B. 200 Individual Income Tax Credit for Use Tax Liability (*Rep. J. Nielson*)
