**MOTION:** Rep. Moss moved to approve the minutes of January 24, 2012. The motion passed unanimously. Rep. Arent and Rep. Newbold were absent for the vote.

**H.B. 212      Dividing School Districts (*Rep. J. Bird*)**

**H.B. 62 Provisions Regarding School Supplies (Rep. K. Powell)**

Rep. Powell introduced the bill which modifies provisions regarding school supplies for elementary school students.

**MOTION:** Rep. Powell moved to amend the bill as follows:

1. Page 2, Line 44:

44 "NOTICE: FURNISHING THE ITEMS ON THIS LIST ~~ARE~~ IS  
OPTIONAL. NO ELEMENTARY

The motion passed unanimously. Rep. Hughes and Rep. Sumsion were absent for the vote.

**MOTION:** Rep. Poulson moved to amend the bill as follows:

1. Page 2, Lines 48 through 49:

48 STUDENT USE. EQUIVALENT SUPPLIES WILL BE FURNISHED AS  
NECESSARY BY THE SCHOOL TO  
49 ALL STUDENTS FREE OF CHARGE { ~~AS NECESSARY~~ ."
