**S.B. 205       Records Access Discovery Amendments (*Sen. C. Bramble*)**

**H.B. 448 Custody Modifications (Rep. G. Hughes)**

Rep. Hughes introduced and explained the bill to the committee.

**MOTION:** Rep. Hughes moved to amend the bill as follows:

1. *Page 2, Lines 32 through 33:*

32 (1) For purposes of this section, "relocation" means moving { ~~150~~ out of  
this state, or 75 miles or more from  
33 the residence { ~~specified in the court's decree~~ of the other parent .

The motion to amend passed unanimously, with Rep. Ipson absent for the vote.

**MOTION:** Rep. Perry moved to amend the bill as follows:

1. *Page 1, Lines 14 through 16:*

14 the custodial parent intends to relocate out of this state, or 75 miles { ~~more than~~

16 ▶ requires the court to determine that a move out of this state or { } ~~of~~

2. *Page 1, Line 19:*

19 move out of this state or 75 miles or more { ~~than 150 miles~~ from the  
residence of the other parent when the court has determined that the move is not in
