Approval of Minutes

MOTION: Sen. moved to approve minutes of the January 30, 2012, meeting. The motion passed unanimously with Sen. Urquhart absent for the vote.

**H.B. 43 Barber, Cosmetologist, Esthetician, Electrologist, and Nail Technician Act
 Amendments (*Rep. J. Dunnigan*)**

Sen. Dunnigan introduced and explained the bill.

Mark Steinagle, Director, Division of Occupational and Professional Licensing answered questions from the committee.

MOTION: Sen. Weiler moved to adopt the following amendment:

1. *Page 3, Lines 67 through 72:*

67 (11) a person who:

(a) is qualified to engage in the practice of barbering, cosmetology/barbering, esthetics, master-level esthetics, electrology, or nail technology in another jurisdiction as evidenced by licensure, certification, or lawful practice in the other jurisdiction;

68 { ~~(a)~~ (b) is employed by, or under contract with, a motion picture company; and

69 { ~~(b)~~ (c) engages in the practice of barbering, cosmetology/barbering, esthetics, master-level

- 70 esthetics, electrology, or nail technology in the state:
71 (i) solely to assist in the production of a motion picture; and
72 (ii) for no more than 120 days per calendar year.

The motion passed unanimously with Sen. Urquhart absent for the vote.

3316 small employer group who is applying for coverage.
