Acting Chair Romero called the meeting to order at 8:11 a.m.

MOTION: Sen. Weiler moved to approve the minutes of the February 24, 2012. The motion passed unanimously with Sen. Madsen and Sen. Urquhart absent for the vote.

H.B. 117 Firearm Modifications (*Rep. K. Ivory*)

Rep. Ivory introduced and explained the bill.

MOTION: Sen. McAdams moved to pass S.B. 117 out favorably. The motion passed unanimously with Sen. Madsen and Sen. Urquhart absent for the vote.

1st Sub. H.B. 52 Notorious Criminal Activity Amendments (*Rep. R. C. Webb*)

Rep. Webb introduced and explained the bill.

Sen. Romero relinquished the Chair to Sen. Madsen

MOTION: Sen. Romero moved to pass 1st Sub. H.B. 52 out favorably. The motion passed unanimously with Sen. McAdams and Sen. Urquhart absent for the vote.

H.B. 99 Background Check Fee Exemption for Firearm Purchase (*Rep. B. Galvez*)

Rep. Galvez introduced and explained the bill.

MOTION: Sen. Weiler moved to pass H.B. 99 out favorably. The motion failed with Sen. McAdams and Sen. Urquhart voting in opposition, Sen. Romero and Sen. Weiler voting in favor, and Sen. Madsen absent for the vote.

1st Sub H.B. 432 Bureau of Criminal Identification Amendments (Rep. J. Seelig)
