Approval of Minutes

S.B. 106 Tobacco Settlement Account Amendments (*Sen. L. Hillyard*)

Sen. Hillyard introduced and explained the bill.

MOTION: Sen. Valentine moved to amend the bill as follows:

1. Page 3, Lines 66 through 73:

S.B. 108 Financial Institution Amendments (*Sen. C. Bramble*)

S.J.R. 8 Joint Resolution on Property Tax Exemption for Military Personnel (*Sen. L. Robles*)

S.B. 116 Armed Forces Property Tax Exemption (*Sen. L. Robles*)
