S.B. 256 Unincorporated Business Entities Act Amendments (Sen. L. Hillyard)

1. Page 3, Line 83 through Page 4, Line 94:

- 83 (4) With respect to a limited partnership that elects pursuant to Subsection (1)(b) to

84 subject to this chapter, after the election takes effect the provisions of this chapter relating
 to
85 the liability of the limited partnership's general partners to third parties apply:
86 (a) before { ~~July 1, [2012] 2013~~ ___ January 1, 2015 , to:
87 (i) a third party that had not done business with the limited partnership in the year
88 before the election took effect; and
89 (ii) a third party that had done business with the limited partnership in the year
 before
90 the election took effect only if the third party knows or has received a notification of the

92 (b) on and after { ~~July 1, [2012] 2013~~ — January 1, 2015 }, to all third
parties, but those provisions remain
93 inapplicable to any obligation incurred while those provisions were inapplicable under
94 Subsection (4)(a)(ii).
